Both races were won handily by Traverse City skipper Ken Lindsay with the help of his well-trained crew, consisting of h's wife, Alice, and son Kenny.


Gordon Cornwell, also of Traverse, pulled down second place, while Bob Newland, first of the Omena skippers, was third.





A Good Sailing Year

Lightning Class skippers had an unusually enjoyable and interesting summer of racing when more boats entered competition than for several years past. All OTYC Lightnings raced, plus Tiger, No. 8282, which Bob Newland chartered from Traverse City. The combination of Bob's capable skippering and Tiger being a good boat would probably have given Bob the season championship had he been able to remain in Omena for enough races.

Bob Morse started off with a bang, winning the first race of the season in his Whistlewing, and getting his name on the old jug which is the trophy for this race. In fact, Bob won both races on the first day.

Bob followed up this auspicious start with enough successes during the summer to enable him to nose out by 1½ points the perennial champion of many previous years, the Johanning-Cherne Queen Bee, and give Bob the season championship and possession of the beautiful Schaefer Trophy Cup until next year. This is the first time in fifteen years of racing at OTYC that Bob has won the championship.

A high point of the summer for the Lightning Class was the set of races for the George S. Smith Memorial Trophy, for which Traverse City Yacht Club brought up to OTYC a large group of their Lightnings. This big event is described, with pictures, elsewhere in this issue.

Annual Meeting - Committee Reports

The 18th Annual Meeting of the Omena Traverse Yacht Club was held at the Club House on August 12, 1965, and called to order by the Commodore, Crampton Finn, with 36 members answering the roll call. It was moved by Joan Roth and seconded by Marilyn Graf that we dispense with the reading of the minutes of the last meeting. Motion carried. Commodore Finn then read his report of the season's activities. His entire report has been filed for the record. He mentioned the annual 4th of July dinner under the supervision of Marion Finn and her committee was well attended and a profit of \$140.00 was realized. The showing of the fireworks had to be postponed due to the high winds and bad weather, but were later displayed on the following Wednesday evening. The Tuesday night dinners for adults only, which were new to our program this summer, were managed by Jane Jackson and Marian Finn and were very well attended. The Wednesday night family dinners were held as usual with Ellie Stephenson and Joan Roth in charge. Harriet White supplied the flower arrangements for the tables for both evenings during the summer, and their beauty helped to give our dinners a festive air. Commodore Finn thanked all who had helped to make the season a success. A "Thank you" also to Ben and Lillian Taylor for their gift of new membership cards in the new design, and for their help in editing the Breeze with Humphrey Jackson.

COMMITTEE REPORTS:

Racing: Bob Morse reported that the F.J.'s had raced on Ingalls Bay, 3 days a week, 2 races a day, weather permitting. Final results are not yet in, but it was mentioned that Jonathan Cain, a new Junior Member, and with a new boat would possibly come in second. A good record for a beginner. More Lightning races were planned for next season. Flags for last year's races were not given out and it was suggested by Linda Cherne that they be placed in the Club House.

The George Smith Memorial Race was held at Omena this year, with skippers and crew being entertained by Helen and Preston Smith after the Races.

Membership: It was reported by Bob Morse that we have lost ten members this year—six by resignation, and four by death. We have taken in two new members, John Kemble and Waldo Abbot, Jr.

Ways and Means: Bob Morse still has maps on hand and they are for sale for \$10.00 each. Ainee Patterson still has sweat shirts on hand. Jim and Ruth Smiley report that they have sold \$10.30 worth of stationery, have 7 packages left. More will be ordered for next year. Burgees and lapel buttons, blazer insignias are available.

House Committee: Bob Reed, Chair-

"During the 1965 season the House Committee directed it's attentions to the most needed jobs. Many of the canvas chairs from the lower deck were broken and useless. They have all been mended, with new Marine blue seats and backs, and should be useful for several seasons. The lower front deck is in bad condition with many of the board badly shredded. However, it seemed advisable to give it a coat of paint; the results were far from satisfactory. During the 1966 season it may be well to give the deck a heavy coat of filler and a topping of deck paint. The deck should not need replacing for several years. The large round table on the lower deck was given a coat of white paint and is new presentable. In answer to numerous complaints about the ventilation of the rest rooms, the committee, (Dan Bradley and Jim Smiley), removed the windows, refitted them so that they may now be opened. Screens were placed on the outside for the first time. The curtain on the stage is at present badly hung and will become shredded and useless unless steps are taken. At present the curtain is rolled to the top and should be left that way during the winter. A permanent solution can be worked out in the spring of 1966. The stage should no longer be a catch all for individual junk. The committee has carefully examined the Club building and equipment and will be prepared to make recommendations to the Board at the first meeting in 1966."

Social and Entertainment: Mary Louise Root, Chairman.

"I have enjoyed serving on the Calendar of Events Committee for 1965. Highlights of the season were the additional adult Pot Luck Suppers on Tuesday nights which were very successful, and several delightful evenings of travel pictures by Bob Morse. Everyone agrees that Bob is a most interesting narrator and shows unusually fine films.

We have had three evenings of Bingo which drew fairly large groups of adults and children. We are now looking forward to our Picnic and Sing on Sunday, August 15th at 6 o'clock. Gwen Pike will lead the singing. A 50 cent picnic supper will be served. A full moon should add to the evening's enjoyment.

We are also looking forward to the Commodore's Reception on Saturday, Aug. 21, at 8 o'clock. The committee consisting of Gwen Pike, Kay Groll, and Martha Smith are working hard to create atmosphere, entertainment, and good food for an evening of fun for all".

Youth Report: Jane Saxton.

"Because we were unable to find a Youth Director for our summer program, Al Cherne agreed to teach a Life Saving Course which was completed in two weeks, with twelve girls and boys receiving certificates. Al also instructed seven sessions of sailing with ten to eighteen young people participating. He was assisted by Bob Newland. Johnnie Hodgson instructed eight sessions each of beginning, intermediate and advanced tennis which were attended by fifteen young people.

We wish to thank Al, Johnnie, and Bob for giving so generously of their time without them we would have had no program at all."

Notes From Omena

November 9, 1965

Tonight is the night of a full "hunter's moon", when old Chief Koo-Koosh's ghost will walk again in what used to be an Indian cemetery near the old town of Louisville, near what is now Peterson's Park. Koo-Koosh meaning pig, was not his real name, but he had earned the title by claiming more than his chief's share of salvage when a schooner was wrecked on neighboring shores. Koo-Koosh's real name has been lost to the memory of man, but not his ghost! Persons of staunch integrity have seen it! More often it has been seen in the horse-and-buggy days, when the startled horse would rear up in the shafts at the sight, and the occupants of the buggy would have the moonlight scared out of them! Nowadays, young people in sports cars may go too fast to get a glimpse of Koo-Koosh's winding sheet, but should they choose to tarry on the night of a full hunter's moon, without doubt they would see his ghost winding its way up from the shore and into the resting place he had occupied before his protesting bones were taken up and re-interred near Menomonee in the UP.

Several local hunters have gone to the UP where the deer season begins one week before it does here. But just in case some remain who believe all the deer, at least the buck, in our woods have not been killed in previous years, I have been busy posting the Clark woods. A pity that I may not post all of Ingalls Bayside, but one may not post another's land without his permission. Few places on Omena Point are posted, and two buck were killed there last year, one a lame deer. If no hunter with a "no antler" permit comes this way, this year, the two doe and a fawn that Liz and Ernie Clark and I watched at twilight drinking from Ernie's harbor, may survive another year. Helen Smith says that the deer do not molest her orchard. The ground vew in our woods affords them abundant food.

The "fall blend" was as glorious as ever, but often displayed its splendor under grey and weeping skies. Many of our OTYC members returned for the color tours: the Morses and friends, the Jacksons, the Stephensons, the Hagemanns, the Grolls, Janet Tate and friends, Marge Rule and the Wickemeyers, the Renz and others. The Weisses stayed late as did the Johannings until Bernice's illness hastened them to Cincinnati for her medical and surgical care. Martha Feely stayed late, also, entertaining the Wm. Feelys, Jr., and a friend Martha Harris who drove her back to Georgia. Beth Marthas attended the last

OTYC supper at the Bowens charming place on Grand Traverse, east of Suttons Bay. The Marthas and the Morses were here, too, for the testimonial supper some of us had at the Foltz home for our Horace Wheeler who has retired as Omena's Postmaster after 17 years of Service. During the fall, the Finns toured Canada eastward to Quebec and Nova Scotia. Preston Smith drove to our eastern states and returned through Canada. He and Helen made several trips to Cincinnati; the Wheelers several trips to Chicago and on to Wisconsin. The Milroys made a trip to California.

Now in November, bare, grey branches are etched against a threatening sky; only young saplings, shrubs and poplars hold clutches of red or gold above the brown carpeted earth. Wailing gales speed the racing white-caps in the bays, and hurl clouds of sand against the snow fences standing guard along northward sloping beaches. Orchard growers like Helen Smith have been hard put to get pickers to harvest the apples before they might become windfalls. Some householders have tried in vain, as I have done, to discover where the mice enter their cottages. Traps are set, and I at least, hope that Ernie Clark, Jack Stephenson or some other hardy male will happen along to release the dead mice from the traps, because Chris now a KU student is no longer here to help.

But despite the chores of late autumn, the social life of Omena goes on. Leona Milrov and Mary Foltz have won prizes in the Traverse City Friendly Garden Club's flower show, for which Mary made the plan. Mary was active, too, in the Zonta Club's holiday festival. The Omena Woman's Club to which four OTYC members now belong, celebrated its 50th anniversary. In the early days, several cottagers of Omena Point and Ingalls Bayside were Geneieve Smith and summer members. Anna Brown are still in the Post Office, Gigi as Temporary Postmaster. Local folk still meet at the post office and discuss local happenings and world events, and then go next door to air their philosophies and firm convictions with Ernie Barth.

The little, century-old Omena church has been the scene of another wedding—that of Marjorie Bader, originally an Omena girl, and Mr. William Gilbert of Denver Colorado. They came from Chicago in order to be married in Omena! Unfortunately, the Reverend William Marbach was too ill to come for the ceremony. The pastor of Omena's Presbyterian Church for 37 summers, Dr. Marbach passed away on Nov. 4, in Melrose Park, Ill. The whole

Omena community was deeply grieved, also, to hear of the passing of our OTYC member Raymond Flett. His cordial fellowship and good works will be long remembered.

Pumpkins, squash and jugs of cider remaining on road-side stands, and the picture of a plump, baked turkey on the wall of Barth's Store are urgent reminders that Halloween has passed and Thanksgiving is upon us. A request from Editor Fumphrey makes us realize that Christmas will be here soon, and that he must have news for the Breeze by Nov. 17, in order "o" you may have the issue before Christmas. To all OTYC members, your friends in Omena and vicinity wish you a Christmas of inner peace and goodwill, - if it be not ringing with gaiety and merrymaking, may it glow with the warmth of lasting friendships and cherished memories. And may the New Year fulfill your fondest dreams!



Summer residents will miss a familiar face at the Omena Post Office next summer as Horace P. Wheeler, postmaster at Omena for the past 17 years reached retirement age in September. Saturday, September 25th Horace was honored at a retirement dinner at the Clark residence on Glen Lake. A Certificate of Retirement from the Post Office Department for "devotion to duty in the course of an honorable career in the United States Postal Service," was presented to Horace. He was also presented a certificate of recognition of his membership in the National Association of Postmasters.

Recently a surprise party and a sterling silver bowl was given to Horace Wheeler, by friends of the Omena-Traverse Yacht Club in recognition of his many courtesies "above and beyond the call of duty" during his years of service as postmaster.
