





Fred Weiss, Sr.

Our Club has lost a fellow member and our community, both local and resorter alike, has lost an energetic civic booster in the death of Fred Weiss, Sr. After several years of ill health, Fred died at the Leelanau Memorial Hospital in Northport, on Aug. 23, 1968.

Among the most lasting results of Fred's work as Chairman or committeeman are the fire house and fire engine in Omena, the erecting of the fire-lane signs along Omena Bay and the surfacing of the road from Omena to the Ray-Linn cottage. Fred never claimed that he did all of the work on these projects, but he was more than noticeible in the promoting and carrying out of the work on them. For the Club, the sidewalk clearance and repair, going from O.T.Y.C. out towards the Point, was a constant item with Fred.

Besides his widow, Mary, he is survived by, among other relatives, his two sons, John of South Bend, Indiana, and Robert of Cincinnati.

Mrs. Lou (Ruth) Bowen of Stoney Point, Suttons Bay died October 12, 1968, at University Hospital, Ann Arbor.
