

# Commodore's Message

Greetings:

After a long cold snowy winter in Cincinnati, spring has opened up with the blooming of the daffodils and magnolias. At this time one's thoughts turns to the summer season with its many varied activities. With your Commodore those thoughts are the plans for the business and activities of the Omena Traverse Yacht Club.

I have word that the ravages of winter elements were not too kind to the tired old dock. As the members will remember, last season the dock committee made tentative plans to try and do something about the dock situation. Because the season was almost over and many of the members had already returned to their homes, a questionnaire was prepared and sent to all members. The object of this survey was to see how the entire membership felt on this matter. We received in return approximately 80% of the questionnaires sent out. A brief review of this survey was as follows: an overwhelming majority agreed that something should be done about the dock. Secondly, a majority agreed to help financially, to a limited extent, though they did or didnot use the facilities. With this information at hand, your commodore authorized the dock committee to have tentative plans drawn. With a blueprint of what we proposed to do, we could get a firm bid as to how much the project would cost. However, the Dock Committee did not feel that they wanted to assume the responsibility of spending money for professional engineering service to design a dock program. A program that would be beyond the ability of the Club financially. That is where the matter now stands. At the first directors meeting this matter will be presented to be acted upon one way or another.

The Sunday picnics and catered dinners will also be continued.

We are looking forward to seeing you all at the 4th of July dinner and sincerely hope that the 1970 season will be a good one for everyone.

# Report From The Treasurer

As the faithful guardian of our monetary reserves, I feel compelled periodically to discuss with you our financial situation. This is an especially sensitive time of the year for the treasurer, for it is the period just before we start adding to our cash reserves with the receipt of membership dues together with a modest income from Breeze ad billings.

I have watched with some concern as our cash balance eroded during the winter to a current level of \$69.15. What really hurt was the real estate tax of \$346.50, an increase of about \$70.00 over the previous year. It requires in excess of 34 adult memberships just to pay this tax. Another major expense of our Club is insurance—about \$600,00 each year, or the dues of 60 adult members. We have purchased some new tables and chairs for the Club at a cost of about \$150.00; 15 memberships were needed to pay for this. The renovation of our Club last year, while admittedly a non-recurring expense, cost in the neighborhood of \$800.00. While most of us would agree that the interior of our Club is much improved as a result of this work, the hard facts are that it took about 80 adult memberships to pay for it.

These are only a few of the expenses that our Club incurs; over the past 12 months I have written almost 100 checks in widely varying amounts. While it is true that we have \$3400.00 in certificates of deposit along with our cash balance, I consider this money a reserve against contingencies of an unexpected nature, and would hope that we would not dip into these funds to meet normal operating expenses.

Now, folks, comes the highlight of this article, which you knew was coming after reading the first few sentences. I shall recommend to our Board this summer that adult dues be increased from \$10 to \$15, keeping the juniors at \$5.00. It's been a long time since we've had a dues increase, but in the meantime our creditors have beefed up their costs considerably. Hopefully, the additional \$5.00 per adult will maintain a closer equilibrium between expenses and income.

I shall soon be filing a tax return for the Club as a Not-for-Profit Corporation. I have no qualms about that classification.

## Rendezvous In Bangkok

Dan and Eloise Bradley have returned from a 26 day and almost 26 thousand mile trip and tour of the Orient.

An interesting letter from Humphrey Jackson enclosed newspaper clippings from the "Bangkok World" with detailed write-ups in recognition of the visit of Dan Bradley IV, grandson of the famed missionary-doctor "Moh Bradley".

Dr. Bradley, who spent 40 years in Bangkok was noted for having introduced the small-pox vaccination in Thailand, for performing the first surgery there in 1836, for establishing the first English newspaper in Bangkok and for his persuasive talent in his Christian missionary work.

In his letter Humphrey described some of the places of special interest to which they conducted the Bradleys, (on a "Jackson Special" tour) and the several dinners and social events, hosted by the Jacksons and other friends, which occurred in honor of the "visitors".

Dan says: "... the main objective was Bangkok where my grandfather was a medical missionary from 1836 to 1873 and where my father lived until he was 22 years old.

The Humphrey Jackson's greeted us at the airport with garlands of flowers a sight for sore eyes in the heat and among all the unfamiliar language and unreadable signs. They made us feel at home in Bangkok, showed us many of the sights tourists usually miss and, with assists from an 84 year old Thai teacher, a /Professor of Agriculture and a Retired Vice Admiral of the Thai Navy, located the spot where the family lived for many years and which my Aunt Irene occupied until 1928 . . . with 100 dogs, they say. Even then the family were a bit odd!!!


It was surprising to find the number of people who knew about Grandfather. In Cambodia, our guide turned out to be the leader of the riots in which the North Vietnamese Embassy was destroyed. He was fascinating! A few days after we left, they deposed the Prince and the airport was closed. The luck of the Irish again!"


