


Commodore's Message

Van Horn Repeats in Windswept Smith Regatta

The 10th Annual George S. Smith Memorial Regatta was held this year on the week-end of August 15th-16th. Well, really, it was run on Sunday, the 16th. The wind on Saturday was such that the Race Committee thought it better to call off the races and hope for calmer weather on Sunday. It didn't turn out quite the way it was planned, but the weather is, after all, one of these little items over which we do not have too much control.

On Sunday, we had seven boats on hand to race - 3 from OTYC and 4 from GTYC. The wind was still up rather high and the waves were running, but it was decided to try for three races back-t-back. Six boats started the race and, as we know, five of them finished. I say "the race" as there was only the one that we were able to hold. While officially this put us out of calling it a regular regatta, still, I think, we all got our usual and full quota of the enjoyment of getting together, racing, talking and eating.

Once the race was well started, the Babel and Van Horn boats took the lead followed by the McGuffin and Lindsay boats and the Cherne and Lyon/Ehrhardt boats. The race was a clock-wise four-legged one, starting down at the Point and going across the bay to just off Foltz's, then to the Club, the Point and back to finish in front of the Club. It was on this last leg that we lost one of the boats . . . John McGuffin's . , , when it was caught in a hard gust and broke its mast. Fortunately nobody was





Proposed OTYC Boat Harbor

Proposed docking of boats O.T.Y.C.

A meeting, October 4, 1970 was held with Officers and Directors of O.T.Y.C. and Sam Walker of Professional Assocoates, designers of a new dock facility as agreed by the membership to draw a feasibility plan, Preston Smith, Al Cherne, Ernest Clark, William Fleming and Norman Johanning attending.

Copies of the planned area were presented and all agreed they had good design and flexibility. Many questions were answered by Mr. Walker.

Definitely, feasibility, usage of our present property lends itself to a breakwater and dockage area for the first segment of 30 boats with ultimate 38 boat basin. Principally, the breakwater and docking area would be made of existing rock, boulders, and ballast material dredged or bulldozed from the old crib and the parking lot, with new parking lot created elsewhere.

Some pilings would be placed in the basin for 20 boats as "tie up" moorings with refinements of more pilings and catwalks to boats coming later. The existing launching ramp would be used in the new concept. The engineer has designed the breakwater to leave an entrance into the basin next to the old tired dock.

The Commodore appointed William Fleming and Ernest Clark, feasible financing; Ernest Clark to obtain a current abstract of titles; Consumers Power Company change of power lines, N. Johanning.

So far, three "Test holes were dug by a local contractor to determine aggregate to be excavated. Plans were distributed to contractor's with specifications, and at this Breeze Issue we have not received bids.

If any conclusions are reached by your officers and board of directors, we will send to you individually any new information. (Our Friend and Director Fred Gorham agreed to facsimile anything worth duplicating.)

Dr. Dan F. Bradley

Dr. Dan F. Bradley, 41, son of Dan T. Bradley, retired vice-president of Harris division of Clevite Corp., died Oct. 31 of a massive cerebral hemorrhage. He has been professor of polymer chemistry at Polytechnic Institute, Brooklyn, N.Y., since 1968. His home was at 32 Livingston Street, Brooklyn.

Services were Nov. 2 in the Brooklyn First Unitarian Church.

Dr. Bradley, a former resident of Shaker Heights, was graduated from Shaker Heights, junior and senior high schools, from Oberlin College magna cum laude in 1951 and received his doctorate from the University of California, Berkeley, in 1953.

From 1953 to 1968, Dr. Bradley was chief of the physical section at the National Institute of Mental Health, Washington, D.C.

He was a leading specialist in biopolymer research and worked with the development and application of polymers in various areas, including pollution control and artificial organs for the body.

His grandfather, the Rev. Dan F. Bradley was pastor of Pilgrim Congregational Church, 2592 W. 14th Street, for 30 years and later president of Grinnell (Iowa) College.

Dr. Bradley is survived also by his mother, his wife Raya, and three children, Dan, Jeremy and Debra.

Sincere sympathies to Dan and Eloise Bradley and Dr. Bradley's wife and children in this sorrowful loss.

Mrs. Renz thanked the Commodore for his efforts on behalf of the club over the past two years.


Mrs. Smith moved and Mr. Bradley seconded that the meeting be adjourned.


