# Commodore's Message

My letter this time has to do almost entirely with two situations. Neither of them are quite what was expected, but, I feel sure, that eventually both of them will turn out all right.

The first one has to do with the Club's docks. This has been a recurring problem through the last several years that has been dealt with, as I mentioned before, mostly with discussion. This last year, however, as a united group we proceeded to actions and, in a manner of speaking, met our problem or problems face to face. Your appointed committee for Dock Improvements spent quite a bit of time and thought during the Fall and Winter in considering the needs and desires of the Club as far as improvements were concerned. Norm Johanning, Bill Fleming, Ernie Clark and Horace Wheeler, together with our architect, Sam Walker, developed a set of plans that, in their opinion, would take the best advantage of our present property and provide what was both needed and desired by our members in the way of expanded dock facilities. The map that was presented to you in the December issue of The Breeze showed, I think, the basic concept of this plan. The full expanse of our shore line was used, except for that directly in front of the Club House, to provide the greatest amount of area for dockage without extending so far into the bay as to make the depth of the water become an over-whelming obstacle and possible future financial hazard. It called for making the present parking lot into a basin or harbor and having the parking back at the end of Omena Lake. The number of slips was thought to be about the greatest number that could be made in the area available. Then we came to the price.

The final figure that was agreed upon, both from the point of how much we could reasonably borrow from the bank and what would buy us what we wanted in good stable construction, was the amount of \$42,000.00. This did not include, I might say, the finishing off of the slips with cat-walks, fencing and buoys. Nor, did this figure take into account any sort of major improvements to the Club building itself. I realize that this is not docks, but, we felt that we should consider what else there might be in the way of sizeable club expenditures that might come up in the near future that would be an added financial drain on our resources.

So, here was what was thought to be a most excellent plan for the docks and a dollar figure, based on actual plans and professional knowledge, to go with it. In the discussions with the bank, it was brought out that, with the present rate of interest, the repayment plan would call for approximately \$6,500.00 per year. This had nothing to do with the final finishing, repairs or any other costs of day-to-day business. This last item included, in our minds, the possible hiring of a Dock-Master.

Under our present methods and views of doing business, income, that is, even taking into account the probable income from dockage fees, there still would have been an amount of some \$4,500.00 per year that we would have to find. This would be almost one and one-half times as much as our present total gross income. Your committee was not able to come up with any sort of feasible plan that would assure us of bringing in this amount of money above our present income. If it had been a case of one or

two years, it might have been thought reasonable to plan on special events and contributions - as assessments are not permitted by the Club's Rules. But the plan had to provide for securing this amount every year for at least 10 years.

Among other things, discussion was had on having a restaurant facility in the club; a bar which would serve liquor; a greatly expanded membership; and a general increase in annual dues. The first two of these possible plans would, of course, bring with them greatly increased costs to the club. Quite aside from the fact that I personally am not in favor of a bar, the committee was not of the opinion that either or both of these projects were a sure "cure all" for our problem. They did not feel that they could present these plans with confidence as being the solution for our financial situation, although it was thought that they might at some time be part of the solution and a definite added attraction for our Club. An increase in membership would, in many ways, only add to the problem. Although, here again, it was thought that such an increase would be benefical to both all of the summer residents as well as the Club itself. Our present dues system is set up to pay for the ordinary expenses of running the Club and to really gain by an increase here would mean almost doubling the current amount.

I took an awfully long time to get to the final result of the committee's work, but I wanted to bring out, in some fashion, part of the reasoning that has gone into the views that the committee has taken.

Without trying to force a "bright side" to all of this, I think that I can say that for the first time, the Club has a good sound professionally drawn plan for expansion of the docks that is adequate to our needs and a realistic view of the cost. Let us then plan that one of our main projects for this next season should be for all of us to work at developing and presenting feasible plans for raising on a continuing annual basis, the amount of money needed to pay for the docks that we want and need.

The second situation is one that has more to do with me personally. I am sure that many of you have already heard, so I will simply state that I am resigning as Commodore of the Omena-Traverse Yacht Club. I regret this very much. The honor and trust that goes with this position is not something that I like to give up easily. Many things have gone into this decision on my part. Some of

them, I'll admit, are feelings, some of them are facts.

While I can't deny that there is quite some effect on me of the great amount of responsibility of being the head of such an organization as we have built up over the last twenty-two years, I am more conscious of the fact that I have not been involved with much, if any, of the Club's doings for quite some time. While I am not, in my own opinion, a "yes man", I haven't, on the other side, done much planning or working with any of the various groups that have gone to make up the active and producing part of our Club. Whether greater attendance at meetings would have made a great change in this, I don't know. Certainly my knowledge would have been greater. if not my involvement.

I will also say that other plans of mine, of even more important effect on me in the future, have not gone as I had thought that they would.

Therefore, because of all my many feelings, my present situation and the uncertainty of the future, I am resigning my position effective as of the 1st of May.

For as much as I can, I shall try to assist in the Club's projects and wish both the Club's Directors and members Good Success.

# Omena - Traverse By-Laws

(As Revised 1970)

The By-Laws of the Omena Traverse Yacht Club were first adopted on Charter Night, July 1948. They were amended in 1954, revised August 13, 1959, and in 1970. The present By-Laws read as follows:

- 1. The order of business at the meetings shall be as follows:
  - a. Roll call
- b. Reading of the minutes of the last meeting, regular and special meetings if any.
- c. Treasurer's report at the annual meeting.
  - d Old Business
  - e. New Business

On all other matters Robert's Rules of Order shall be followed.

- 2. No alcohol shall be permitted on the premises. No person, member or non member shall be allowed on the premises while under the influence of intoxicating liquor.
- 3. Each member shall be responsible for the conduct of his guests and for the members of his family.
- 4. All members of recognized Yacht Clubs shall be welcome at all times while the Club is open.
- 5. All Club activities after eight o'clock in the evening shall be chaperoned. The Club will be open at eleven o'clock in the forenoon and close at eleven at night, except for special occasions the Board of Directors may alter the opening and closing time. The Club shall be locked when not officially in use.
- 6. An applicant may become a member of the corporation by the following procedure:
- a. He must first be proposed by a member and seconded by another member.
- b. Completion of application on membership blank.
- c. Application must be approved by the Board of Directors, a quorum being present.
- 7. Membership may be terminated for failure to pay dues, or to abide by the Charter or By-Laws or for violation of the rules of good conduct, after such member is given written notice of the charges against him and after he has been given an opportunity to be heard.

- 8. New Membership rates: Initiation Fee \$50 per family; Regular Membership \$15 per person; Junior Membership (over 14 \$5; Guest membership \$5; Breeze subscription \$2.
- 9. No business may be transacted at meeting of the Board of Directors without a quorum present. (See By-Law 16)
- 10. The Commodore shall call and preside at the meetings of the Corporation and shall be subject to the will of the Board of Directors. He shall have all the usual powers of a corporation President.

The Vice-Commodore shall call and preside at the meetings of the Corporation and the Board of Directors in the absence or disability of the Commodore.

The duty of the Rear Commodore shall be to call and preside at meetings of the Corporation and Board of Directors in the absence or disability of the Commodore and Vice-Commodore.

The office of Secretary and Treasurer may be held by one person.

The Secretary shall have charge of the Corporation's records and correspondence and keep a record of Minutes of the Corporation and Board of Directors.

The Treasurer shall be at least 35 years of age and shall receive, record and safeguard all funds of the Corporation, keep a bank account of the Corporation's funds and pay it's bills upon countersignature of the Commodore. It shall be his duty to so account for all expenditures of the Corporation and all its income so that the books may be readily audited.

11. Voting by Proxy shall be allowed at any meeting of the Corporation at which By-Law or an amendment to the Charter is to be voted upon, provided, however, that the officer or members calling such meeting mail a written notice to each member at his last known address thirty days in advance of such meeting and stating the time, place and purpose of such meeting.

- 12. Memberships:
- a. Each adult shall become a voting member of the Club. (No initiation fee shall be charged in changing from family membership to individual membership.)
- b. Unmarried children of members over 14 years of age and up to 21 years of age expecting to use the facilities of the Club must become Junior members without payment of initiation fee.

- c. Junior Membership dues shall be \$5.00 annually.
- d. Junior membership does not entitle the member to vote on Club business.
- 13. Officers shall take office September 15th and hold office for a period of one year.
- 14. Guest Memberships:
- a. A guest member is defined as one in residence one month or less. Each adult Guest member shall pay dues of \$5.00 and each Guest between the ages of 14 and 21 inclusive shall pay \$2.50. Guest members shall be expected to take out full membership after the 2nd year as a guest member.
- 15. The fiscal year shall be January 1st to December 31st., inclusive.
- 16. Term of service of Board of Directors
- a. The Directors at large shall be elected for a period of two years and may be re-elected for a second term of two years after which they may not serve on the Board until a period of one year has elapsed, unless the member at large becomes an officer of the Club in which case he may serve an additional two years.
- b. Three Directors shall be elected for the regular two year term in 1959. Two Directors shall be elected to serve for one year in 1959. Thereafter Directors shall be elected for a period of two years.
- c. Four Board members shall constitute a Quorum of the Board.
- d The immediate Past Commodore and the Editor of the Breeze shall be exofficio members of the Board.
- e. An Honorary Member of the Board may be elected by the members upon recommendation of the Board.
- f. A vecancy on the Board may be filled by the Board of Directors.
