

The 26th Annual Meeting of the Omena-Traverse Yacht Club was called to order by Vice Commodore Joe Buell at 8:22 p.m. There were 47 voting members present, plus 9 proxies.

The Improvement Fund has a cash balance of \$589.08 plus Certificates of Deposit for \$4,700.00 making a total of \$5,289.08. The Dock Improvement Fund has a cash balance of \$6,636.65. The new boat cost \$375.00 and a dolly to assist in launching the Sunfish boats is going to be purchased. A total billing of \$4,276.00 for Membership Dues was sent out to the 104 family units in the club.

Mr. Finn moved that Paragraph 2 (Use of Alcohol on Premises) be stricken from the revision and left as is. Motion carried, but followed by quite some discussion.

Mr. Jones moved that we vote on each By-Law as we went along. Mrs. Lewis amended this to limit discussion to 7 minutes on each By-Law. The amended motion was carried.

Paragraph 10 (Officers)

Paragraph 11 (Committees) with the change of sub-paragraph B to read as "Waterfront Facilities Committee: This committee shall be responsible for all waterfront facilities and their use".

Paragraph 12 (Memerbship) with the substitution of "and/or" for "and" each time it appears.

Paragraph 13 (Guest Privileges) which is to read: "A guest may be granted Club privileges at the discretion of the Board".

Paragraph 14 (Voting) which is to read: "Any proposal to amend the Articles of Incorporation or the By-Laws of the club shall be distributed in written form between 50 to 90 days prior to voting to all members at their last known address, with notice that such proposal will be put to a vote at the next Annual Meeting. The annual meeting of the members of the corporation shall be held on the first Sunday in July each year at which time Directors shall be elected as provided in the By-Laws. Fifteen members shall constitute a quorum on all matters evcept that a meeting may be adjourned by a majority of any number present. Other meetings of the members shall be called and held as the By-Laws shall provide. The right to vote shall be limited to those members 18 years of age and above. Voting by proxy shall be permitted at any meeting of the members of the corporation.

ARTICLE X

The Articles of Incorporation may be amended by a two-thirds majority vote at any regular or special meeting of members of the corporation; provided that no motion to amend the Articles shall be considered at any meeting unless written notice setting forth the substance of the motion shall have been sent to the members at their last known addresses or otherwise personally delivered to them not less than 60 days before the meeting.

The above proposals were accepted by the membership.

New Business: Under the new By-Laws, Directors for the following year are to be elected at the Annual Meeting and Mr. Root, Chairman of the Nominating Committee, first asked for nominations from the floor. He then presented the slates of nominations for Directors for the various terms of office. These terms are all to start on September 15, 1973.
