## Commodore's Message

Overall, the winter has dealt kindly with O.T.Y.C. Aside from some minor damage to the porch, the clubhouse weathered the storms and wind quite well. The corner of the "L" formed by the end of the dock and the breakwater, which was cracked and loosened last summer, has fallen in, but the main portion of the dock remains, and the beach used both for swimming and for the Sunfish races appears to be in basically good condition. (I regret that I did not have the opportunity to visit Omena this spring; the preceding information was supplied by our Editor, who generously patrols our turf when most of us are not able to do so.)

In accordance with a decision made by the Board last summer, the Shugart Construction Company of Traverse City has been given a contract for electrical and carpentry repairs to the clubhouse, which, we expect, will be completed before July 1st. As of this date, no decision has been reached concerning the replacement of the dock. Consultation with a sample of club members during the Fall indicated that it would probably be very difficult to raise the funds for dock replacement quickly enough to permit construction before this summer. While some members were generous indeed in their offers of loans to assist in this project, the predominant feeling was that the responsibility for the basic dock facility should be spread as broadly as possible over the membership of the club. Consequently, it now appears that a successful plan for dock construction is much more likely to be based upon the modest financial support of most or all members rather than upon substantial loans or gifts from a few.

While not all committees have as yet been determined for the coming season, I am happy to report that Mary Helen Ray will serve as Chairman of the Entertainment Committee, Holly Smith

as Chairman of the Membership Committee, and Rat Renz as Chairman of the new Committee on Clubhouse Interior Decoration and Design. This new committee, which Mary Foltz will assist as a consultant, will be the subcommittee of the House Committee responsible for all interior improvements of the clubhouse not of a structural nature. Additional committee memberships will be announced at the Annual Meeting.

One of the problems in developing the most effective roster of committees for a club like O.T.Y.C. in that our schedules are so varied. Partly in order to help us to better plan committee assignments, an information blank is provided which we hope each member will take the moment or two to fill out and return to Preston Smith. The blank asks you to tell us when you expect to be in Omena, which committees, if any, you would be interested in serving on, and a few other points of information which will help us to plan the summer schedule. Even to know simply when you will arrive would be very helpful, so please do take the time to reply.

In the calendar of events are several new entries this season. There will be a Club Dance on July 26th and two Youth Dances, one in July and one in August. As consequence of a suggestion made by several members, there will be a general membership meeting on Aug. 6th. The purpose of this meeting is neither to duplicate nor replace the Annual Business Meeting, but to provide a forum for discussion of Club affairs by members who are here in August, but not in July. Members not present at the Annual Business Meeting may, of course, participate by means of proxy ballots, but it is important that the Club also have the benefit of the "in person" discussion of Club affairs by all its members. Several members have expressed to me concern over what they view as lack of communication between the "July group" and the "August group", which may affect adversely our sense of cohesiveness and unity. Hopefully the August meeting will prove a step in the

direction of improving communication among us.

According to the 1973 revision of the by-laws, the Nominating Committee is to publish in the May Breeze the names of at least two candidates for each of the Board vacancies. Many members have felt this to be an unwise requirement, in that it would probably prove quite difficult to secure as many as six candidates who would be willing to run against each other for the three Board vacancies each year. Such a procedure, it has been observed, may be more suitable for larger, more impersonal organizations than for our relatively small club in which close friendships endure over many years. This particular provision of the by-laws has not been followed since its enactment, and it is the recommendation of the Board that it be rescinded by a proposed by-law revision to be acted upon at the Annual Meeting. The present nominating committee consists of Hazel Taylor (Chairman), Kathy Bosco, Dan Bradley and Preston Smith. Elsewhere in this issue is a report concerning the candidates which they propose for the three vacancies to be voted upon July 6th. While they are continuing the custom of nominating only three candidates, any number of additional nominations may, of course, be made from the floor during the meeting.

During the past summer, your Board devoted considerable study to the Club's financial security in view of the ravages of inflation over the past several years and the possibility that basic operating costs will continue to rise at a rapid rate. The Board concluded that even a "survival" level of operation cannot be sustained by the present dues income, and unanimously recommended a by-law revision to increase annual dues by a modest amount and initiation fees by a greater amount. As you know, the Club's present dues are extremely modest compared to those of other clubs -- and while the observation is correct that O.T.Y.C. operates only a two-month

season, it is equally true that many of our expenses extend over significantly longer periods, including some over twelve months. The Board earnestly solicits your support of this measure, which we feel to be essential for the future security of the Club. You will find the complete text of the proposed by-laws amendment on another page.

A second by-law amendment is proposed which concerns the manner in which dues adjustments may be made in the future. There appears to be considerable merit, I think, in placing the basic dues structure under the control of the membership rather than of the Board. This is presently accomplished by the by-law which stipulates the exact amount of the dues. At the same time, the Board experiences some difficulty with this arrangement because of its relative inflexibility; even a nominal "cost-of-living" adjustment in dues presently requires the considerable effort involved in effecting a by-laws revision. The amendment proposed to ease this problem would leave the basic dues structure in the by-laws, but would permit the Board to determine, if it deemed that circumstances warranted it, in any

## Proposed 1975 Amendments to the By-Laws of O.T.Y.C.

1. Change Article 9, paragraph c, to read: Nominations for the Board of Directors shall be made by a Nominating Committee appointed by the Commodore with the advice and consent of the Board. The Nominating Committee shall designate one candidate for each vacancy. The report of the Nominating Committee shall be published in the May Breeze and voting shall be by ballot at the Annual Meeting.

2. Change Article 11, paragraph e, to read: **Nominating Committee:** This Committee shall be appointed in such time that its membership may be published in the December Breeze, so that it may receive suggestions for nominations from the membership prior to publication of the Committee's report in the May Breeze.

3. Change Article 8 to read: **Initiation Fees and Dues:** Paragraph a. The initiation fees and dues, effective the Spring billing, 1976, shall be as follows —

Single Adult Membership	
annual dues: .....	\$25.00
Family Membership annual dues	
(required of all married members; no dues for children under 14): .....	\$50.00
Junior Membership annual dues	
(for members between their 14th and 18th birthdays) .....	\$ 6.00
Adult Guest Membership annual dues (limited to one month for two years) .....	\$15.00

given year, an annual increase of dues of not more than 10% of the previously established dues. If approved, this amendment would give the Board some helpful flexibility in coping with the Club's financial needs in periods of rising operating costs. Relative to the inflationary rate of recent years, I believe the proposed limit of 10% represents a reasonable request, and hope that you may judge this amendment also to be a constructive one.

We shall look forward, as always, with the greatest pleasure to being in Omena this summer and to seeing old friends and meeting new ones. I am confident that the entertainment, youth and sailing programs will be as enjoyable as our hard-working committees can make them. And, who knows, perhaps this will be the year that the great Buell sailing dynasty will be seriously challenged.

Youth Guest Membership annual dues (limited to one month for two years) ..... \$10.00  
Initiation fee for either family or single adult membership ..... \$150.00  
(The initiation fee will apply to all new members except those whose parents previously paid an initiation fee while the new adult member was a child or youth member. Individuals whose memberships have lapsed are eligible for readmission upon payment of the current initiation fee or the accumulated annual dues over the period since dues were last paid, whichever is the lesser amount.

4. Change Article 8 by adding new paragraph b to read: The Board of Directors is authorized to increase dues in any following year by not more than 10% of the current year dues. Such discretionary action to increase dues within the limit of 10% shall require a two-thirds vote of the Board. Any increase greater than 10% shall require amendment of the By-Laws.

5. Change Article 12, paragraph a, to read: A family membership shall include a husband and wife and their children under the age of fourteen.

**NOTE:** Article and paragraph designations follow those of the 1973 revision as printed in the supplement to the Breeze of May, 1973. A complete, integrated set of By-Laws is being prepared. We hope that it will be available for distribution at the Annual Meeting.

He is survived by his wife, a daughter Mrs. Margaret Deal, a son John Charles Eichhorn, two sisters Mrs. Hazel Taylor and Mrs. Helen Reed, eight grandchildren and one great-grandchild.

Burial was in the Omena cemetery.

A summer visitor to Omena and a friend to many of our club members, Charles Eugene "Gene" Wheeler died on February 3, 1975. He was 77 years old at the time of his death.

Prior to his retirement, Gene was the Engineer in Charge of Maintenance and Operation of the Calumet Plant of the Metropolitan Sanitary District of Chicago for over 40 years. He was a graduate of the University of Wisconsin and a veteran of World War I.
