



The involvement of many Club members in committee work brought personal rewards and new success in Club activities.

The Happy Hours which preceded the Wednesday suppers each week served again as a medium of communication and new friendships.

Not only did the children enjoy the sailing, tennis and swimming instruction but the program paid for itself! Bill gave more than his required time helping with Bingo, group sings, and twice cleaned out the Store Room mess. We thank Bill for his undying interest in O.T.Y.C.

The limited use of the Club House by the larger community was a new plan in 1978. A small donation of money was given to the Club as a means of meeting the cost of operating the building for the special function. The Board felt that much good will toward O.T.Y.C. was generated in the surrounding communities. There were four wedding receptions, the Northport Leland Lake Leelanau Schools Senior Prom, the North-

It may be possible to furnish the upper porch so that the beautiful view of Omena Bay may be enjoyed up high.

## Mature Sailors Revolt

As the years go by, more and more sailboats are seen drifting by on the bay. Small children learn how to swim well enough to pass swimming safety tests and are finally permitted to attempt to learn how to sail. The hardest lesson for a sailor to learn is that some young punk whom we have watched take his first steps, chew on the rocks and sand in Omena, contract poison ivy, become strong enough to lift the other end of a sailboat suddenly learns enough about sailing (and is light enough weight-wise) that when it comes to racing, that little punk skims over the water and passes the more mature sailor and leaves the mature sailor behind completely becalmed.

There have been many grumblings about this fact of life for at least six years. Finally, on August 10, 1978, the great day arrived when the Omena Middle Years Amateur Sailing Society was born. A list of requirements was widely publicized. The age minimum for skippers and crew was 30. Proof of age was required. Proof was established by showing gray hair (or roots), swollen knuckles, wrinkles or birth certificates. Sailors were allowed on the water with a crew or they could sail single-handed. Rumors were that single-handed boats would have a St. Bernard or other similar type passenger placed on board, so many sailors scurried to line up their over-30 type crew members.


