





# In Memoriam Ben L. Taylor

The Omena community was saddened to learn of the death on August 5, of Ben L. Taylor. Mr. Taylor, who was 82, was the husband of Lillian Taylor. Mr. and Mrs. Taylor have operated Taylor Printing Company of Traverse City since 1932 and we have been privileged to have them as printers of the BREEZE for many years.

Mr. Taylor was born in Grass Lake, Michigan on February 21, 1897. He grew up in Fremont, Michigan where he graduated from high school in 1915. He and Lillian were married in 1918. He had worked on several city newspapers in Michigan prior to his coming to Traverse City in 1929. He was secretary of the Traverse City Chamber of Commerce until his purchase, in 1932, of what is now the Taylor Printing Company. He was active in civic affairs in Traverse City and in Suttons Bay, where he had lived since 1947.

Among his survivors in addition to his wife, Lillian, are a son, Ben I. Taylor of Suttons Bay, and a daughter Mrs. Anne Cain of San Francisco.

Mr. Taylor will be remembered by his many friends in the Traverse Bay area and we extend our sympathy to the members of his family.

### Treasurer's Report

We had a rather successful year financially. All families are up-to-date in their payment of dues except four. All outstanding bills have been paid with sufficient funds on hand to pay our 1979 taxes and also insurance premium. Insurances were rewritten via the George Anderson Agency and the amount of insurance on the building was raised from \$40,000 to \$70,000. Funds of the Club, not needed for operating expenses, are in a savings account.

Invoices for dues, etc. for 1980 will be mailed shortly after the 1st of the year. Again, the Board of Directors at their August 13 meeting felt that it was necessary to raise dues 10% to keep in step with inflation. At the meeting for the Club membership on August 8, the Commodore informed those in attendance of the need for replacement of the rotting wood bulkhead at the waters edge in front of the Clubhouse. Those members at the meeting were in substantial agreement.

A contract has been let to Boone & Boone to provide a steel bulkhead and the cost of this contract is \$4,875.00. Work is to be completed on June 1, 1980. As a result of this capital expenditure, which is sizeable for our Club, it is necessary that we impose a \$20.00 assessment for each adult member of the Club. Now when you get your invoice for dues, you will know what is happening. Thanks for reading!






